College Board and RIDE want to ensure that all students receive the accommodations in their IEP and 504 Plan on the RI SAT School Day and PSAT 10. This will help College Board and RIDE staff ensure the student is receiving the right accommodations on test day.

Directions: Because you entered an accommodation into SSD Online that is often entered in error or is mistaken for another accommodation, you must complete this questionnaire. There are multiple sections to this questionnaire. Complete *only* the sections that apply to the accommodation you are requesting. Once complete, upload the questionnaire into SSD Online.
