4. SASID	Must be 10 digits. State Unique Identifier assigned in the E-RIDE system.	Y (Required for all High School Students)	Number	Used to verify uniqueness on students that do not already exist in the RI-CATS database. Verified against the E-RIDE database.
5. Program	This is the unique number of the program offered by the school. See RIDE provided list of program numbers.	Y	Number	Must match the number assigned to the program by RIDE. If the program number does not exist for the school represented in the file, the record will not be added.
6. Participation Level	This is the level of participation in the program and must be either: PC – Program Completer P – Participant, or C – Concentrator	Y	Character	If the participation level is not supplied, then the record will not be added to the database. Participation Level will be subject to additional validation rules during data verification.
7. Program Entry Date	This is the date that the student originally entered the program. Valid date format is mm/dd/yyyy.	Y – Only required on new students	Date	The program entry date is required for all new students. Students participating in the same program for previous years will have their record updated with the program entry date from the previous year's record. The program entry date must be filled with a valid date prior to submission to RIDE.
8. Initiated Date	This is the date upon which the student began receiving services for the school year reported. Valid value is mm/dd/yyyy.	Y	Date	This initiated date must fall within the school year reported. The initiated date must be filled with a valid date prior to submission to RIDE.
9. Program Exit Date	This is the date that upon which the student no longer received services. If the student is a program completer, then this field must be filled. Valid date format is mm/dd/yyyy.	Y	Date

11. Program Status	This is the student's status within the program. 13. FTE Days/Week	This is the number of days/week that the student is participating in a vocational education program. The maximum number is 5. 14. FTE Weeks/Month	This is the number of weeks/month that the student is participating in a vocational education program. The maximum number is 4. This validation is only performed if the school uploading the data is a secondary school.	Y	Number	FTE weeks/month must be supplied on all student records prior to submission of data to RIDE. If no number is supplied – or a number greater than 4, the value of 0 will automatically be assigned.
15. Termination Date	This is the date upon which the student no longer received services. Valid date format is mm/dd/yyyy.	Y	Date	If there is a termination date, there must also be a program end date. This rule will be enforced prior to submission of data to RIDE.
