<b>Grade</b>	<b>Grade-Specific Standard</b>
<b>Kindergarten</b>	W.K.1 Use a combination of drawing, dictating, and writing to compose opinion pieces in which they tell a reader the topic or the name of the book they are writing about and state an opinion or preference about the topic or book (e.g., My favorite book is...).
