RHODE ISLAND BOARD OF EDUCATION

The Rhode Island Board of Education met on Monday, October 7th at the Bristol Warren Regional School District, Bristol, RI. Chair Eva-Marie Mancuso welcomed everyone and called the meeting to order at 5:45 p.m.

4. **REPORT OF THE CHAIR**

Chair Mancuso informed the Board of two speaking engagements she attended recently. The first, the URI Colloquium on September 17th. This discussion on The State of Education in Rhode Island was moderated by Elizabeth Harrison, the host of the *Morning Edition* and education reporter for RI National Public Radio. The discussion included Commissioner Deborah Gist, President Carriuolo, President Dooley and Scott McKay from RI National Public Radio.

Chair Mancuso added that she had also attended the New England Board of Higher Education's (NEBHE) Legislative Meeting in Boston.

5. REPORT OF THE COMMISSIONERS

5a. Updates and issues affecting local and national education.

Commissioner Gist echoed Chair Mancuso's earlier comments and thanked the Bristol Warren Regional School District for hosting today's meeting, with a special thank you to Superintendent Thies, Paul Silva, School Committee Chair, and Principal Donald Rebello.

The Commissioner was excited to have been a part of the 2nd annual Innovation Powered by Technology Conference which took place last Saturday. She, along with Board Members,

Dr. Callahan, Mr. Guida, and Mr. Santos joined with educators, students, and friends of education from across the state. They heard from some leading national thinkers on how technology is changing education, and also heard first-hand reports from Rhode Island educators who have taken the lead in bringing technology into the classroom and into the lives of their students and their families.

To help clarify any confusion with the NECAP testing and the Diploma System, Commissioner Gist announced that the Department of Education has developed a short "myths and facts" sheet to help students, families, and the public at large understand the truth about the use of assessments, diminish public fears and concerns, and provide students with the confidence needed to earn a diploma. The Commissioner indicated that the handout entitled "The Truth About NECAP" would be available as part of her Blog and distributed as necessary.

The Commissioner reported that the "Educators in Action" group, a group of highly committed educators from across the state, will be holding a conference on Saturday, October 26th from 8a.m. to 2 p.m. at the New England Institute of Technology. The Commissioner encouraged all educators to attend this event, and welcomed any member of the Board wishing to attend to do so.

The Commissioner reported that she will be meeting with Governor Chafee and Board members to put together an Education Autonomy Working Group. This group which will include a broad group of stakeholders and will meet monthly from December 2013 until June 2014. They will be charged with making specific recommendations on ways we can increase innovation and autonomy in improving teaching and learning in RI.

Lastly, Commissioner Gist reported that she has been asked by the Commission on Presidential Scholars to nominate students from Rhode Island as 2014 U.S. Presidential Scholars. This is an enormous opportunity for high school seniors and she is seeking the districts' help in selecting the best possible nominees from Rhode Island.

5b. Updates and issues affecting local and national higher education.

Clark Greene, reported that there was no budget proposed for the Office of Higher Education. The office will continue to operate through the end of fiscal year 2014 until a new administrative structure is established.

Mr. Greene announced that some of the staff with the Office of Higher Education have transferred within the system. Annie Messier has already transferred to CCRI while Ron Cavallaro will be transferring to CCRI on November 1st. Michael Trainor submitted his resignation from state service effective November 1st.

With respect to the tuition waiver audit, a work group has been established and has met with the Board's tax counsel relative to the references to the US Tax Code that are presently in the Board's Tuition Waiver Policy. The group is in the process of drafting proposed language changes for that policy.

Mr. Greene reported on the number for the Instate Tuition for Undocumented Students during the 2012-2013 school year. A total of 148 applications were received and 115 of those students were accepted for admission. Of the total students accepted for admission, 74 students enrolled. Students who were not accepted either had missing essential documentation or did not meet the admission requirements.

6. DISCUSSION ITEMS

6a. Higher Education Governance - Update

Clark Greene shared an update with the Board of the draft governance proposal. He explained that the Board has been charged with developing an administrative structure for Higher Education. The primary goal by the General Assembly and the Board is to increase coordination and collaboration throughout the Rhode Island education system. Additionally, the Board must also address a wide range of policy, governance and coordination issues within the Pre K-12 and higher education systems individually. With this proposal the Board remains as currently configured, a single board of Education for pre K-12 through post-secondary education, to focus on broad system-wide goals and specific cross-cutting issues. Board members will be assigned to one of two new entities, a Pre K-12 Council and a Council for Post-Secondary Education to address policy, governance and coordination within the Pre K-12 and Higher Education systems respectively. Each Council will have full statutory authority for governance and regulation.

Board members Callahan and Bernstein expressed their appreciation and thanked Mr. Greene for the work being done on the new Higher Education governance structure and the collaboration between K-20.

7. ACTION ITEMS

7a. Approval of the RIDE FY 2015 Operating Budget and 2014 Supplemental Budget

Commissioner Gist presented RIDE's revised 2014 Supplemental and 2015 Operating budgets. As a reminder, she stated that the State Budget Office instructions require three budget proposals: a Fiscal Year 2015 current-service-level budget; a Fiscal Year 2015 constrained budget, with a 7-percent reduction, equal to a cut of approximately \$1.4 million; and a Fiscal Year 2014 (the current fiscal year) cost-neutral revised budget.

Commissioner Gist clarified several issues and answered questioned posed by Members Barajas, Callahan and Purtill. Mr. Purtill stated that based on his feeling that the funding formula is not funding many programs appropriately, he will be voting no on the approval for these budgets.

On a motion duly made by Antonio Barajas and seconded by Jo Eva Gaines, it was

7b. Approval of the Higher Education Operating Budget FY 2015

Clark Greene presented Public Higher Education System's unrestricted and restricted budget requests for FY 2015, the revised budget for FY 2014 and the State Budget Office mandated FY 2015.

Member Grande proposed a motion to amend the original motion to include a 3% salary increase for faculty and staff at the higher education institutions. Jo Eva Gaines seconded the motion to amend.

Each of the three presidents gave an estimate of how much more in funding would be needed at their respective institutions to accommodate this request. President Dooley's initial estimate would be an additional \$4M at the University, while both Presidents Carriuolo and Di Pasquale indicated their estimate to be \$3M at their respective institutions.

Member Guida added that he would like to have the proposed amendment be clear that any additional funds needed to support the 3% increase come from state funds and that any increase in salary not be supported by a tuition increase.

Member Purtill asked whether using the term "as long as it comes from the general fund" would bind the Board down the road on other negotiations.

Chair Mancuso clarified that this is the first submittal of the budget to the Governor. This request will come back to the Board and at that time the Board can make a decision on whether or not to give raises and where the money will come from.

Member Grande explained that he would like to transmit to the Governor that the Board believes the faculty and staff at the institutions deserve a 3% raise.

Chair Mancuso expressed her concern that this would bind the Board's hands in negotiations. She would like to see this expressed to the Governor as "we believe our faculty and staff deserve a raise" with no percentage number attached.

President Dooley indicated that he feels sending the General Assembly a message of high priority for public education to receive a significant increase in compensation for its faculty and staff rather than attach a percentage to it as percentages needed may vary by institution.

Vice Chair Guida stated he would like the possibility of tuition being raised to accommodate any raises be discussed, as he is perfectly comfortable asking for an increase without identifying a certain percentage, but he feels it should be clear whether or not there is going to be a stipulation tied to it as to whether or not it could derive from an increase in tuition.

Member Gaines stated that she feels very strongly that the Board should not increase tuition for this. She thinks the State should stand up to the plate and pay for higher education as well as K-12.

Chair Mancuso asked if it would advance the question if the she sent a statement to the Governor that the Board unanimously supports our faculty however we have to balance it with the increased tuition rather than a specific increase.

Member Grande reiterated his desire to have the motion include a 3% increase as he believes that delivering a budget with a number is far more powerful.

Member Maaia cautioned on the danger of debating or even making a recommendation by a motion of this Board for something under the umbrella of collective bargaining.

The Chair then stated that there is an amendment on the floor to the motion recommending a 3% increase of faculty and staff at all three institutions be added.

On the motion duly made by Michael Grande and seconded by Jo Eva Gaines, it was

Chair Mancuso assured the Board that she will add to her letter to the Governor the Board's strong feeling on faculty and staff salaries.

Commissioner Gist presented the three new charter school proposals that she is recommending for preliminary approval. She explained that preliminary approval is when the Board, as the state's sole authorizer, approves the conceptual design for the school. Preliminary approval does not grant applicants the authority to operate as a school. The school must come back to the Board after meeting all the requirements for readiness and secure final charter approval.

Andrea Castaneda, Chief of Accelerating School Performance, answered questions from Members Purtill, Grande and Callahan on the financial impact of the Charter Schools and the Funding Formula.

The College's total enrollment for the Fall 2013 semester stands at 17,699. The President noted that there has been a strong growth in minority students which is presently up to 35%.
