



Directions to Access Cost Proposals from Vendors for High Quality Curriculum Materials and Professional Learning

The State of Rhode Island has posted a Request for Proposals (RFP) and collected a number of cost and technical proposals in response. Vendors submitted proposals for approved curriculum materials, professional learning to support the implementation of high-quality curriculum materials, or both. Local Education Agencies (LEAs) in Rhode Island planning to procure new materials and train their educators on implementation can use the Master Price Agreement (MPA) that includes these proposals.

The following curricula and professional learning services are currently offered by vendors on MPA 581:

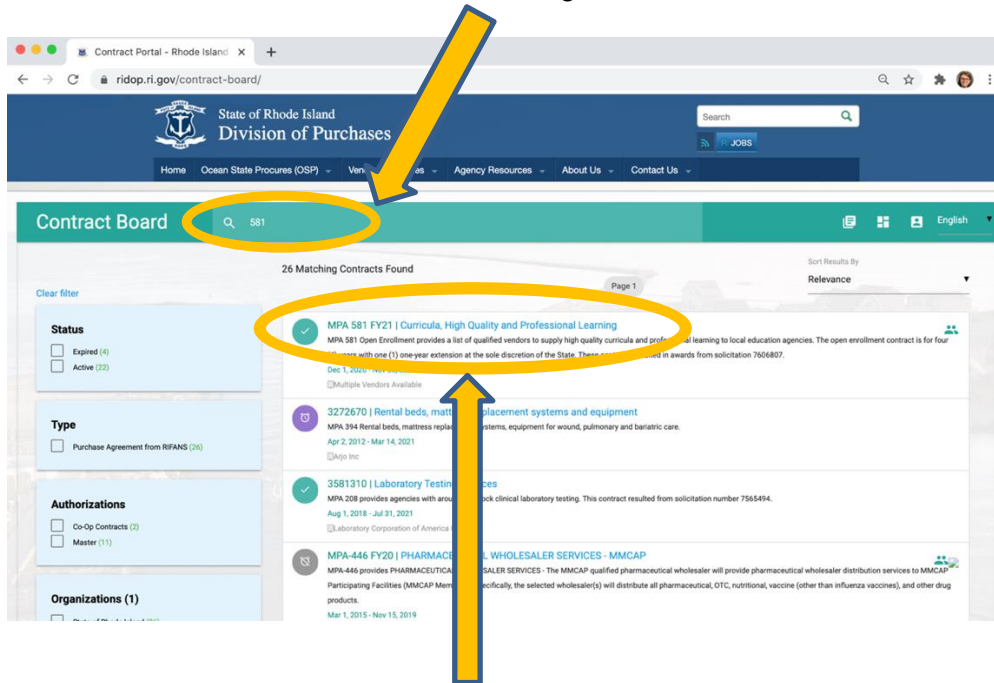

Since LEAs are considered “Political Subdivisions” within the state, all ordering and billing for these items shall be between the vendor and the school district. Neither the RI Department of Education nor the Department of Administration will be involved in the transaction. Any state agency purchasing materials or services should follow the instructions in Section 2 of the MPA 581 User Guide that is included in the attachments.

7. The prices are in effect until the MPA expires on November 30, 2024.
